RTII (Response to Instruction and Intervention) is an instructional support system designed to give students the individual support they need to learn, no matter where they stand academically.</p>	<p>Screening results are not typically distributed outside the school due to their formative nature, but parents can request the information from the school as needed. <p>ACCESS for ELLs</p> <p>Grades K-12 (English language learner students only)</p>	<p>Feb. 17 – April 3, 2020 (state test administration)</p> <p>Tests are untimed, but typically about 180 minutes total time</p>	<p>The state-mandated ACCESS for ELLs assessment measures English language proficiency levels and is used as one criterion to determine when ELLs have attained the language proficiency needed to participate meaningfully in content area classrooms.</p>	<p>Scores and other information from this assessment are delivered to the schools for distribution in August. Testing will be paper/pencil in grades 3-4 and online in grades 5-8.</p>	<p>Quick score results are typically available soon after the test is given so teachers can calculate final grades. Later the state releases more detailed individual student reports. These are distributed by district office staff to schools and shared with families in the fall. Statewide dual credit challenge exam scores must be reported on the student's official high school transcript for the purpose of awarding credit at the postsecondary institution.</p>
